Chief King reported the members from both Companies participated in the annual Santa visits and tree lighting ceremonies; bailout trailer was on-site for three nights, but rained out for one; TL49 is out of service for repairs; the department was on call for NWP in December; the Department will not host the Mt. Pleasant Chief's meeting this year; TL49, R9 and E83 will be designated as mutual aid apparatus; thanked the Board for an enjoyable 2015 and looks forward to 2016.

Comr. McCarthy reported majority of VFC #1 Captain's wishlist items have been received with the exception of the hose which is on backorder; watermain project on Legion Drive is progressing; Ruscon is working on three pumps identified during the pump test; requested the District host the March 23rd Association of Fire Districts of Westchester County meeting.

Comr. Ciancio reported 2482 was repaired and inspected; TL49 passed testing but requires many and the rear outer tire was replacement; R9 auto-eject is not ejecting when the truck starts; three RIT packs for VFC #1 are out of service; proposed a picnic for members on June 4th

Comr. Hoffarth reported the PILOT check from the Town was received; 4th quarter report sent to DES; all members completed physicals for 2015.
