It was moved on a motion made by Comrs. Deegan/Bonanno to accept the Chief's report for March 2020. MC. Activity report for February 2020: alarms 20 for 119 hours; meetings 2 for 80 hours; misc. 7 for 85 hours; drills 6 for 176 hours; training 3 for 85 hours. Total: 545 hours.

Chief Kohany reported 2/12 members responded to a commercial alarm at 15 Skyline Drive that was quickly upgraded to smoke in the building caused by cooking; 3/7 members responded to 115 E Stevens Avenue – MPPD arrive and upgraded to odor of smoke in the building; 3/21 will be the last day for bailout training – any member that did not complete it by 4/1 will be exterior; CPR/AED course 3/23; 3/31 both companies will participate in ConEd training on the new prop at WCFTC; new buildings at Pepsi will have water shut off for construction; dual response with NWPFD is being updated – a truck and an engine will respond to calls of smoke or conditions or worse; met with contractor working at 42 Columbus Avenue and the Department's comments/concerns will be addressed; provided Board with recommendations on approaching commercial alarms and MVAs during COVID-19 and moving forward.

Comr. Ciancio report Stop the Bleed added to AED/CPR 3/23; ordered district maps for each location; the Chief and members of Independent Fire Co. cleaned up HQ store room, office and bays – expired gear donated and sent to Guatemala through a contact from AAA Emergency Services; mailed Installation Brunch invitations; the cost for a new, larger compressor is \$73,000 – the Department will use the County's for the time being; Captain DiPrinzio will be purchasing 2 nozzles; Chief purchased and distributed sanitizer for company and HQ locations – must wear gloves when using as it is NOT for hands; will purchase Tyvek suits from AAA; have not received any information from WCDES on building closures or measures to protect members from COVID-19; attended ceremony atop of Kensico Dam with County Executive Latimer,

Comr. Deegan reported 2019 Service Award certifications are prepared for filing once they have been posted for 30 days; will follow-up with Bill young on 2nd letter to NYMC and if no response from them by April 7th, how to pursue a lawsuit.

Comr. Bonanno reported worked with Emergency Responder products on new uniform accessories for members and Fire Squad shirt and pants.

Chairman Sciliano reported progress.

It was moved on a motion made by Comrs. Ciancio/Bonanno to accept the application for membership for Anthony Sarni. MC.

Rich Thomas inquired about use of the compressor through the County.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Bonanno/Ciancio to adjourn the meeting at 8:27pm. MC.
