It was moved on a motion made by Comrs. McCarthy/Ciancio to accept the Chief's report for July 2020. MC. Activity report for June 2020: alarms 26 for 187 hours; meetings 2 for 108 hours; misc. 18 for 148 hours; drills 5 for 132 hours; standby 2 for 17 hours. Total: 592 hours.

Chief Kohany reported 6/11 apparatus attended a moving up ceremony parade for Columbus Avenue School; 6/24 apparatus attended a graduation parade for Valhalla HS; 6/26 TL49 participated in a flag detail for deceased Bedford Hills FD member; Target Solutions online training module is up and running and members have been using it; all parades have been cancelled except for Ossining; thanked the members for cooperating with protocols during the pandemic – reminded all to continue with disinfecting, wearing masks and social distancing at all times; new key fob system is functioning – glitches are being worked out by Security World, and will not affect members' access; is updating SOPs, but will need some information from the Commissioners mostly concerning insurance – once fully updated, would like them available for the members; requested that the Commissioners and Presidents of each company review and update the bylaws – also having them available for members once complete; airpack flow test scheduled 8/6-8/7.

Comr. Ciancio thanked Chief for assistance while dealing with medical issues; workshop scheduled 7/29 to discuss Capital Project purchases; new ladder truck is scheduled to be delivered before the end of 2020; Columbia Doctors will dedicate a few days just for department physicals in the near future – they are not currently taking appointments; members are encouraged to go to their own doctors for a physical at this time.

Comr. McCarthy would like to schedule a preliminary budget meeting; WiFi is not working in District building.

Comr. Deegan reported LOSAP audited and payments were approved; 2019 audit completed.

Commissioner Bonanno reported the District has a 3 ISO rating per Benedict. Cafagno & Grillo; FDM will host a presentation for members on protocols when injured on a call or during a department activity; VFC #1 would like Captain's office to be fobbed rather than having a physical key.

Chairman Sciliano reported the District building roof has been repaired.

There was a discussion concerning the 2020 Inspection to have just a walk-thru of the apparatus with the Commissioners and Officers.

There was a discussion on pursuing DEP to pay for the cost of charging the chlorine meters since they are only used for calls to their property.

It was moved on a motion made by Comrs. Ciancio/McCarthy to purchase Gold Page in EFD commemorative journal for \$200.00. The page will name all members of the Board, Chiefs and Officers. MC.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Deegan/Ciancio to adjourn the meeting at 8:54pm. MC.
