It was moved on a motion made by Comrs. Sciliano/Deegan to accept the Chief's report for May 2021. MC. Activity report for April 2021: alarms 15 for 105 hours; meetings 2 for 80 hours; misc. 7 for 113 hours; drills 2 for 48 hours; 2 fire prevention for 10 hours. Total hours: 420

Chief Kohany reported 4/27 the department responded to a car into the woods with entrapment; 5/9 the department responded to a fire on the roof of 350 Columbus Ave; 5/26 there will be a department drill at WCFTC; members from both companies have completed their AED/CPR training; members are reminded to continue to wear masks at all department activities and follow Covid guidelines; the Memorial Day and Pleasantville Parades have been cancelled.

Comr. Ciancio reported new, more professional looking physical forms for members to take when using their own doctors are now available; rented gear has been returned; the County contract has not been signed as the letter to County Executive Latimer and his colleagues has been sent; the district PO Box address will cease as of 6/1 – all vendors notified of address update and letterhead will be updated; suggested setting up the Defensive Driving course and holding it on separate nights for each company; received check from the Town; new TL49 is scheduled to return to Garrison for additional repairs.

Comr. Deegan reported the audit has started as of 4/19; thanked 2484 for managing the department website.

Comr. Bonanno reported Comr. Sciliano has taken over the insurance committee; Girl Scouts would like to plant flowers in the front of the District building.

Comr. Sciliano reported he submitted 2 claims to the insurance company; discussed with 2481 piggybacking off the City of White Plains for bid for roof repair/replacement.

Chairman McCarthy reported he spoke with the Town of Greenburgh regarding turning on the water on Ronald Ct; 2 new batteries placed on E83; scheduled a showing of the old TL49 for possible sale; all generators have been serviced – HQ unit requires \$850.00 repair or replacement of entire unit; the siren on the bridge has been removed due to it being damaged, and requires replacement; Dine & Drive may be moved to some time in the fall; delivered memorial candle from the AFDSNY Annual meeting and certificate to Arlene Primerano; 5/26 WCAFD monthly meeting will be offered in person and via zoom from district HQ; AFDSNY Annual and Fall meetings will be combined moving forward; suggested a letter is sent to the Town on the dangers to pedestrians of the trenches on the road in front of Independent Fire Co. With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Ciancio/Bonanno to adjourn the meeting at 8:17pm. MC.
