It was moved on a motion made by Comrs. Deegan/Bonanno to accept the Chief's report for July 2021. MC. Activity report for June 2021: alarms 32 for 185 hours; meetings 2 for 70 hours; misc. 10 for 132 hours; drills 3 for 114 hours. Total: 501 hours.

Chief Kohany reported members attended the Mt. Kisco Parade on 7/9 – the department was award trophies for Best Rescue and Best Chief's car; 6/22 members went on a walkthrough of NWPFD Washington HQ; AAA will be doing SCBA flow testing 8/9 and 8/10; Captains were asked to remind the Fire Squad members of the rules on curfew; Westchester County will host firework at Kensico Dam 9/2.

Comr. Ciancio reported Luis Herrera would like to take the EMT Course and once completed will be reimbursed; new trunk radios installed; portable radios in 2481 and 2482; TL49 is back in service; ordered new SCBA masks for both companies – VFC #1 has yet to pick them up; suggested workshops be held before each meeting; requested the activity sign in sheets are more detailed and filled out properly to avoid delays in assigning credit due; set up the Inspection for 9/26 at Boun Amici at 2pm; sent follow-up letter to County Executive on Grasslands IMA increase; suggested updating SOPs and relaying them to members; rules and regulations must be enforced to the membership to avoid any legal liability; will draft a letter for both companies on the legal drinking age in NYS.

Comr. Deegan reported LOSAP audited and payments were approved; 2020 audit completed; meeting of the investment committee with financial advisor Cheryl Johnson, reviewed investment policy and discussed investment recommendations.

Commissioner Bonanno requested the year to date budget numbers to prepare for the preliminary budget meeting scheduled in August.

Chairman. McCarthy reported 9/12 the Chamber of Commerce will host Mt. Pleasant Day, rain date 9/26; suggested the department host Oktoberfest this year on 10/3 or 10/10 in the Village; contacted AFDSNY on Annual Meeting refund – they requested phone records as proof of having tried to contact them prior to the refund cutoff date.

It was moved on a motion made by Comrs. Ciancio/Deegan to accept the resignations of Kyle Grant and Paul Oliva III in good standing. MC.

It was moved on a motion made by Comrs. Ciancio/Bonanno to approve the investment recommendations of Cheryl Johnson. MC.

There was a discussion on EMT recertification.

There was a discussion on dedicating 1 member from each company to handle uniforms and accessories for their respective company.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Deegan/Ciancio to adjourn the meeting at 8:54pm. MC.
