Chief Kohany thanked all members who came out during Hurricane Ida; 9/2 fireworks at Kensico Dam were cancelled; 9/12 Mt. Pleasant Day, rain date 9/26; 9/11 Memorial on 9/10 at Hawthorne FD; 9/11 Memorial at Kensico Dam on 9/11; E84, R9 and TL49 to get 9/11 photos taken at 9/11 Memorial in NJ; 9/18 Ossining Parade – mutual aid will be set up for the day; 9/26 Inspection at Buon Amici; Fire Prevention Week 10/3-10/9; Oktoberfest and Open House tentatively scheduled 10/3; no member is to enter Woodfield Cottage until the building is confirmed secured; requested sending a letter to the County on calling employees to work over the radio; requested sending a letter to the County on deployment of mutual aid.

Comr. Ciancio requested permission to host WCAFD meeting 10/27; will assist Chief in drafting 2 letters requested; will reach out to news media on not receiving a response from the County on the increase requested for the Grasslands Reservation.

Comr. Deegan reported LOSAP audited and payments were approved; 2020 audit completed; meeting of the investment committee with financial advisor Cheryl Johnson, reviewed investment policy and discussed investment recommendations.

Commissioner Bonanno made arrangements with Nu-Way Cleaners to have work on Class "A" uniforms done there.

Comr. Sciliano reported the roof contract has been signed – work will begin 9/15 and conclude on 10/13.

There was a discussion on paying the Mt. Pleasant Water District bill for the fire hydrants. It was agreed to pay the bill.

Lt. McGuinn was sent to as a representative of Valhalla Fire Co #1 to discuss the displeasure of the company on the purchase of third new Engine. Comr. Bonanno requested to table this issue until he and Chairman McCarthy could discuss further with the company.
