It was moved on a motion made by Comrs. Bonanno/Sciliano to accept the November Chief's Report as read. MC. Activity report for October 2021: 36 alarms for 277 hours; 5 drills for 78 hours; 2 meetings for 66 hours; 1 training for 12 hours; 8 misc. for 67.50 hours; 15 fire prevention for 192. Total hours: 698.

Chief Kohany reported that 10/26 the department responded to a fire on Cleveland St – commended members for knocking it down quickly; 11/2 members participated in fire

extinguisher training at EF Academy faculty; members participated in bailout training and fit testing – Captains will coordinate with remaining members requiring testing and training; 11/15 Mt. Pleasant Chief's meeting will be held at Independent Fire Co – requested food be provided; Santa visits will be scheduled around December school concerts; Chief's nominating meeting 12/2; 12/5 tree lighting in the Village.

Comr. Deegan reported he spoke with Bill Young about Grasslands and it will be 2-3 weeks before Bill can return any information on it; Joe Butler recommends the 2020 surplus, \$112,744.00, be moved to either the Capital Reserve or Building Reserve, or some into each.

Comr. Sciliano reported roof contractor ELQ will start roof replacement 11/12 or 11/15 – would like to have a pre-construction meeting.

Comr. Ciancio reported the RedNMX system constantly losing connection; requested a crew to clean up HQ and items be deemed surplus for sale; FEMA projects are still in process.

Comr. Bonanno reported the account with NuWay Cleaners has been set up.

Chairman McCarthy reported 11/29 old TL49 will be ladder tested, \$2,000.00; spoke with someone on moving the siren; due to material shortages the construction of new E81 and E82 have been moved to begin June or July 2022 tentatively; 11/13 WCAFD Dinner, \$75 per person; contacted Mike Snow to service door alarm/fob system.

It was moved on a motion made by Comrs. Bonanno/Deegan to transfer all the \$112,744.00, 2020 surplus money into the Building Reserve account. MC.

There was a discussion on trunk radio switch over/programming.

2483 expressed his opinion on the importance of trunk radios; asked about new pagers.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Sciliano/Deegan to adjourn the meeting at 8:31pm. MC.
