### **CHIEF**

Activity report for November 2023: 32 alarms for 263 hours; 4 drills for 99 hours; 2 meetings for 72 hours; 1 training 8 hours; 11 misc. for 89 hours; 1 fire prevention for 9 hours. TOTAL HOURS: 540

Assistant Chief DiPrinzio reported the department responded to a FAST call at Elmsford; Engine 81 has been delivered; knox box added to 1 Zeiss Dr and I Am Responding program; CAD updated with correct district line on W. Stevens Ave; Cascade is out of service, members may fill bottles at Thornwood FD; countywide phone outage, backup means of notification was made; Santa visits scheduled 12/18-12/20; Ronald McDonald House Christmas part 12/14; members have been reminded to complete their annual training; requested a policy on EOC activation; discussed ECHO response calls.

It was moved on a motion made by Comrs. Deegan/McCarthy to accept the Chief's report for December 2023. MC.

### **COMMITTEES**

Comr. Bonanno absent.

Comr. McCarthy reported wreaths have been purchased and hung at district building; letter on water district vote has been delivered to all residents; E81 delivered – will have training scheduled with Hudson Valley Fire; E82 delivered scheduled in the near future; tablets for new engines to be delivered by February; old siren to be removed; generators were serviced; strainers and foam inductors ordered for new engines.

Comr. Sciliano reported he received 2 quotes for the new driveway; contacted 3 vendors for quotes on HVAC system, only received a response from JNR Heating & Cooling \$15,500.

Comr. Deegan reported \$3,500.00 grant award from Stayin Alive will be used towards EOC upgrade; 2021 surplus transferred to Capital Reserve fund; 2022 surplus to be transferred in 2024 \$112,609; 2023 surplus not determined until the annual audit

completed; LOSAP payments in 2024 approximately \$165,000; LOSAP life insurance policy terminated due to overfunded investments.

Chairman Ciancio reported AAA on site 12/11 to repair cascade, new compressor is required; 12/8 AED/CPR training for members – they must recertify annually to qualify on use of the equipment; names of members missing physicals were given to the Captains – they will be suspended as of 1/1/24 until completed; members are not showing up to calls.

#### **Unfinished business**

Officers and Assistant Chief were sworn in for 2024; there was a discussion on appointing John McGuinn as Chief for 2024.

It was moved on a motion made by Comrs. McCarthy/Sciliano to have the \$70,000 that was moved to Ameriprise, be put into a flex savings certificate that will mature in July. MC.

# **Comments from the floor:**

Ex-Chief Eugene Bratton – discussion on the following: asking for clarification on Chief's nomination; equipment purchases with Comr. McCarthy; requested minutes be available more timely; volume of the fire alarm and the necessity of it – Assistant Chief explained its purpose and remedies other departments have put in to place for it.

Lt. Mario DePalma – discussions on the following; issues with inaccuracies of the minutes; that he was unaware that only 6 items from equipment list had not been purchased; that new engine cannot be in service due to bottles not being filled; email from John McGuinn on missing equipment; opinion that most apparatus are not NFPA compliant.

Anthony Olenchak submitted a bill for reimbursement.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Deegan/Sciliano to adjourn the meeting at 9:04pm. MC.
