SECRETARY'S REPORT

Secretary Ciancio reported she provided City MD with a worker's comp claim # they were unable to obtain from the insurance company to process a claim from July 2023; no response from the Town on 2 letters sent per the June meeting; finally and successfully followed up on a request to from October 2023 to update a portion of the RedNMX section that has now been completed; provided Board with copies of Resolution 64 – Instant Use Technology Policy; updated group life roster for renewal; still working with auditors to complete the audit by 6/30.

It was moved on a motion made by Comrs. Sciliano/McCarthy to accept the Secretary's report. MC.

CHIEF'S REPORT

It was moved on a motion made by Comrs. Ciancio/Sciliano to accept the Chief's report for June 2024. MC. Activity report for May 2024: alarms 30 for 264 hours; 3 drill for 96 hours; 2 meetings for 62 hours; misc. 9 for 135 hours; 2 fire prevention for 2 hours. Total hours: 471.

Assistant Chief DiPrinzio reported 5/4 the department was dispatched to a motor vehicle fire in Kensico cemetery; 5/18 the department responded to an MVA with ejection on Sprain Brook Parkway; 5/18 the department responded to an MVA needing door prop – victim was extricated; 5/30 the department assisted Hawthorne FD with rescuing a male student from the roof at 226 Linda Ave; 5/31 TL49 was requested to relocate to BHFD; 5/27 the department participated in the Memorial Day Parade; 5/31 the department participated in the Pleasantville Parade and TL49 won best appearing tower ladder; 6/13 live burn drill scheduled with Chappaqua FD; 6/20 meeting on the annual fireworks on 7/3; looking to meet with VVAC captain on a joint training for ECHO calls and adjusting their EMS mutual aid responses; talked to Roger King about WMC switchboard giving incorrect address and other information; would like to schedule a department drill focusing on apparatus placement; working with Commissioner Lester on replacement for RedNMX and getting Zello project up and running.

COMMITTEE REPORTS

Comr. Sciliano reported the door prop is almost complete and ready for pick-up and training.

Comr. McCarthy reported E81 is at Hudson Valley having the body damage repaired; cleaned up memorial in Village; Town meeting approved 10% tax break for first responders; discussion on changing age for driver's to be 21 to drive; unhappy that the insurance required internet filters have caused sites to be blocked at VFC #1 being that they pay for their own service — would like them removed and that the District put in a separate cable line for their equipment so the blocks do not affect the internet usage; all generators have been serviced.

Comr. Ciancio reported 4 sets of new gear was ordered from Morningpride – requested permissive referendum for \$60k for new gear; unsure why he received a call from AAA that a member was getting measured for gear instructed by Chief McGuinn; the gear is no longer being ordered from AAA and no one should be going there for gear measurements or ordering; will contact Goosetown for leasing quote of new radios; members should not be expressing their displeasure with vendors directly but instead contact the Commissioners to have it addressed; discussed the value of having had added the cancer screening to the on-site physicals as it did pick up something on one of the member's whose own doctor did not detect it; asked Chairman Bonanno to follow-up with Captains on members who are missing any pieces of uniform equipment; was called to testify at

the trial on the MTA train accident 9 years ago; requested a permissive referendum for \$50k for additional equipment that will be required for the new Chief's cars.

Chairman Bonanno reported he will begin looking at the budget and scheduled a preliminary budget meeting workshop 7/29 at 7pm.

It was moved on a motion made by Comrs. McCarthy/Sciliano to approve a permissive referendum for \$60k for new gear. MC.

It was moved on a motion made by Comrs. Sciliano/Ciancio to approve a permissive referendum for \$50k for additional equipment on the new Chief's cars. MC.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Sciliano/McCarthy to adjourn the meeting at 9:00pm. MC.
